

Investment Structure Under the UNC Retirement Programs

(Effective December 19, 2025)

Retirement Programs

The University of North Carolina currently sponsors and maintains the following retirement plan programs:

- (a) The Optional Retirement Program of The University of North Carolina (“ORP”);
- (b) The University of North Carolina Section 403(b) Plan (“403(b)”);
- (c) The University of North Carolina Code Section 457(b) Plan (“457(b)”);
- (d) Senior Administrator Retirement Program of The University of North Carolina (“SAORP”); and
- (e) Senior Athletic Employee Retirement Program of The University of North Carolina (“SAERP”).

The ORP, SAORP, and SAERP each include The University of North Carolina Qualified Government Excess Benefit Arrangement under the Internal Revenue Code (the “Code”) Section 415(m) to capture contributions that would otherwise be payable under the ORP, SAORP, and SAERP. For purposes of investments, these arrangements are considered part of the plans.

The Tier Structure

The following are the funds that are included in each of the tiers.
