**UNC System, US Army Sign Partnership to Spur Student Interest in STEM Fields** 

On June 18, U.S. Army Combat Capabilities Development Command's Army Research Laboratory, the Army's corporate research laboratory also known as ARL, formally signed an educational partnership agreement (EPA) with the UNC System. The purpose of this initiative is to stimulate student interest in STEM (Science, Technology, Engineering, and Math) disciplines, particularly in areas of relevance to the Department of Defense's mission.

The EPA is a master agreement designed to facilitate new partnerships between the Army and individual UNC System institutions. It allows institutions, colleges, and even departments, to expedite their own potentially groundbreaking EPAs with ARL.

"This agreement reflects the UNC System's long and productive partnership with the U.S. military," said UNC System Interim President Bill Roper. "Together, we will develop life-changing opportunities for our students and faculty. At the same time, our collaboration will lead to innovations that will protect liberty at home and abroad."

The Division of Governance, Legal, and Risk sponsored the second annual UNC System Safety and Security Conference, May 30-31, at UNC Asheville's Highsmith Student Union. This year's theme was *Preparing for the Unexpected*.

More than 200 employees from the System's constituent institutions received training and shared best practices related to safety and security in the areas of Clery, Title IX, student affairs, law enforcement, environmental health and safety, emergency

management, and legal. The two-day conference offered more than 30 breakout sessions, a keynote, and two plenary sessions.

The keynote session was led by Peter Lake, professor of law, Charles A. Dana Chair and director of the Center for Excellence in Higher Education Law and Policy at Stetson University College of Law. His topic was *Preparing for the Unexpected: Future Trends in Campus Safety and Security*. The opening plenary, led by Dr. Gavin Smith, professor at NC State University, was *Making our Campuses Safer and More Resilient: Preparing for Hazard Mitigation and Disaster Recovery*. The closing plenary with Tim Wiseman, assistant vice chancellor for Enterprise Risk Management & Military Programs at East Carolina University, focused on *Connecting Campus Safety and Security with Enterprise Risk Management*.

The conference, organized by a subcommittee of the UNC System Campus Security Committee, was the implementation of a recommendation issued in the 2013-14 Campus Security Initiative.

The event was hosted by the BESST Team and Human Resources, and led by LinkedIn Relationship Manager Becca Starks.

LinkedIn is an online networking site that allows professionals to make connections and search for job and networking opportunities. Launched in 2003, the company was bought by Microsoft in 2016. To date, LinkedIn has 610 million members, 30 million companies, and 20 million jobs listings.

Here are a few takeaways from the session:

- **1. When setting up your profile, be sure to add a photo.** Photos increase your connections. Actually, your profile photos gets you 9X more connections, 21X more views, and 36X more messages.
- **2. Add your industry.** Add the industry you are currently working in. If you are a jack-of-all-trades, include more about your expertise in the experience and about section. There are 300K industry searches per day.
- **3. Draft a compelling summary**. This is your elevator pitch letting others know more about your career accomplishments and aspirations. When in doubt, tell them where you've been, where you are right now, and where you want to go.
- **4. Don't leave out the details:** Include details to your experience. Share samples of your work by using photos, videos and presentations. Add volunteer interests and specific skills.
- **5. Grow your connections**. Share your authentic voice by including topics you are passionate about and post frequently (every day or at least once a week). Be informal, but stay professional. Start a conversation about what interests you, ask for a recommendation or pose a thought-provoking question to spark dialogue.

## Military and Veterans Education Talks on the Hill

Siobhan Norris, program manager for Military and Veteran Education for the UNC System, traveled to Washington, DC in June to meet with key members of Congress and veterans' committee staff on Capitol Hill.

Norris met with House Veterans' Affairs Committee staffers, Justin Vogt, director for the Economic Opportunity Subcommittee and Julian Purdy, another staff member. She also met Sen. Thom Tillis staffers Bill Bode and Michael Buttner, and with David Shearman, who works for the Senate Veterans' Affairs Committee. Norris talked to the Capitol Hill staffers about all the efforts the UNC System is undertaking to help military veterans and their family members transition into successful college careers at our universities.

During her visit, Norris also served on a U.S. Chamber of Commerce *Pathways to Prosperity* panel titled, "The GI Bill & The Military Family." This event commemorated the 75th anniversary of the GI Bill. Norris shared her experience as a veteran and military spouse and how she took advantage of her GI Bill benefits to transition from soldier to UNC System graduate.

## **Team Spotlight: State Authorization Unit**

The UNC Board of Governors is authorized to issue licenses to nonpublic and out-of-state institutions to conduct post-secondary degree activity in North Carolina. Licensure is required by law and the State Authorization Unit, located in the Spangler building, is made up of three individuals who are responsible for administering this process. The team is responsible for licensing programs at institutions that have physical campuses in North Carolina, such as Northeastern and ECPI University, as well as institutions that have administrative offices in the state, like Bellevue University and Western Governors University. The team also licenses programs that originate from institutions in other states, but require a clinical placement, internship or field experience that will take place in North Carolina. The licensure process includes an extensive application that requires institutions to speak to the adequacy of their curriculum, facilities, faculty qualifications, library resources, student support services, finances, organization, business practices and much more. The process also includes a site visit to the institution, in which the State Authorization staff make a determination concerning the merits of the application. If an institution satisfies each standard, the staff then makes a recommendation to the UNC System Interim President Bill Roper or his designee, who then must get approval from the Board.

Licensed institutions are regularly monitored and visited, and they must undergo a review each time a new program or site is added, or if an institution undergoes a change in ownership. Another

function of the State Authorization unit is to review religious programs and institutions for an exemption from licensure standards. Religious exemption is not automatic, but requires an application for approval and ongoing annual reporting to ensure that institution do not offer programming or otherwise operate outside the terms of their exemption. The State Authorization staff puts consumer protection above all else and works diligently to keep students protected from fraudulent business practices and sub-par degree activity. They coordinate with state authorization units in other states, accreditors, the Department of Education, SARA-NC, and professional licensing boards to carry out this mission.

#### Meet the team -

**Dan Harrison** is the senior associate vice president for Academic and Regulatory Affairs. Dan leads the State Authorization Unit, lending his extensive experience as a higher education attorney to licensure application and compliance reviews, changes in ownership and the prevention of disorderly closures that jeopardize student records. He oversees the unit, which advises the Board of Governors on licensing non-public and out-of-state colleges, and the State Approving Agency, which authorizes colleges to offer GI Bill financing in the state. Prior to working at the System Office, Dan was an attorney focusing in post secondary education law at the US Department of Education, worked in private practice, and served as an Air Force JAG. He has a bachelor's degree and a Juris Doctor from UNC-Chapel Hill. When he's not working, Dan enjoys activities in his college town with his wife and children.

**Kaity McNeill** is the director of Licensure for the State Authorization Unit. Kaity provides guidance to institutions seeking licensure, while planning and conducting site visits to institutions. Prior to working at the System Office, Kaity worked both in student affairs and academic affairs at multiple UNC System institutions. Kaity is proud to be a product of the UNC System, having earned her bachelor's degree from Fayetteville State University and her MPA from North Carolina Central University. Outside of the office, Kaity enjoys traveling and spending time with her extended family.

Andre S. Richardson, Ph.D., is the licensure and state authorization program specialist. Andre is responsible for working with religious institutions seeking exemption from the licensure requirements to offer post-secondary degree programs in a religious vocation and works with licensed institutions, managing and implementing the details of the process for granting licensure to non-public institutions that wish to conduct post-secondary degree activity in North Carolina. Andre has worked in education for 23 years, in both higher education and P-12 organizations. He has worked as an associate vice president for Student Affairs, dean of students, and as a program officer for the U.S. Department of Education in Washington, DC. Prior to attending college, he served on active duty in the U.S. Navy for five years, and deployed to the Persian Gulf for Operations Desert Shield and Desert Storm. He earned his Ph.D. in Leadership Studies from NC A&T State University, a master's degree in English Education from the College of Notre Dame of Maryland, and a bachelors degree in English from Shaw University.
